Cash balances month over month increased by approximately \$230,00. The increase can be attributed to the receipt of Homestead/Rollback reimbursements during December.

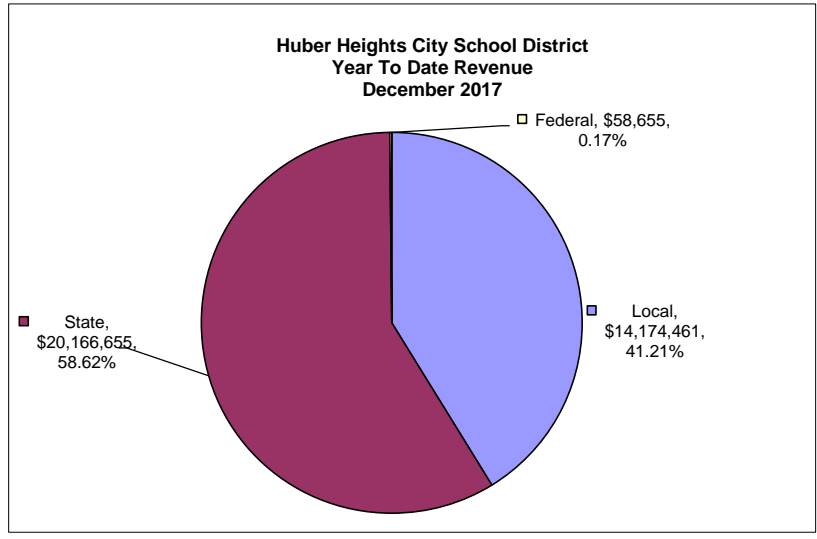
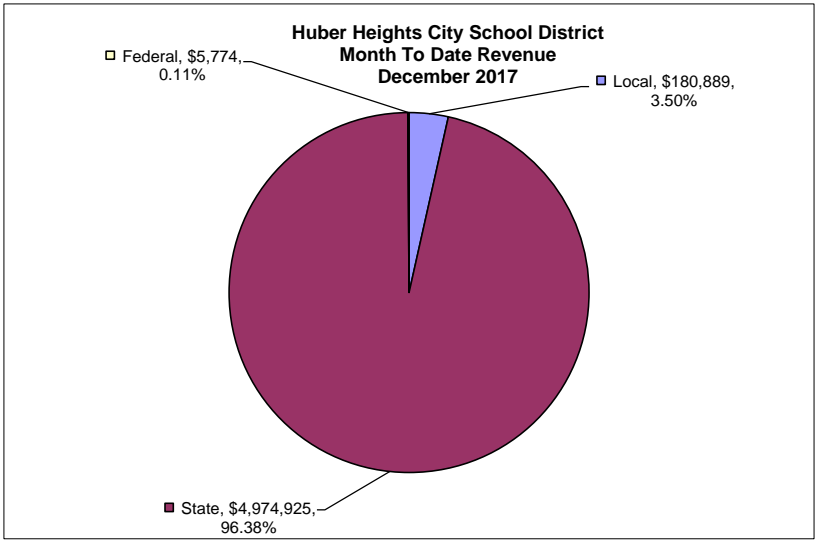

- 1. Local - MTD totals:** the increase as compared to the same month in the prior year is primarily due to the receipt of approximately \$30k more in interest revenue.  
**YTD totals:** increase as compared to the prior year is primarily due to receipt of payments in lieu of taxes from the City of Huber Heights for tax years 2013-2015 totaling \$652k.
- 2. State - MTD totals:** the increase as compared to the prior year is due to the fact that the payments from the State for Homestead and Rollback receipts were received in December 2017, whereas in the prior year, they were received in November. **YTD totals:** the increase as compared to the prior year is due to the fact that under House Bill 49 the district's funding increased slightly as compared to the prior year.
- 3. Federal - MTD totals:** the increase as compared to the prior year is due to timing of receipt of Medicaid dollars. In the prior year, Medicaid dollars were received in December. **YTD totals:** the decrease as compared to the prior year is primarily due to the decrease in the amount of erate dollars received as well as the timing of Medicaid dollars received. In FY16/17 erate dollars received to date totaled \$53k whereas receipts in the fiscal year to date are \$31k; likewise Medicaid dollars received FY16/17 year to date were \$38k and in this fiscal year to date they are approximately \$8k.
- 4. Salaries and benefits - MTD and YTD totals:** the increase for both the month and YTD as compared to the same periods in the prior year is due to 3% raises given to employees effective 8/1/2017 in accordance with the negotiated agreements and slightly higher employee headcount.
- 5. Community Schools - MTD and YTD totals:** the decrease is due to declining enrollment in community school students.
- 6. Purchased Services - MTD and YTD totals:** expenditures for purchased services will vary based upon the need for such services. Month to date payments are lower than the prior year based upon timing of payments - in the prior year certain mental health services provided were paid in December, whereas in the current year, they were paid in November, thus year to date expenditures are somewhat consistent.
- 7. Supplies and materials - MTD totals:** expenditures for supplies and materials will vary based upon ordering patterns. Expenses in the current month include diesel and unleaded fuel purchases for transportation during the months of October and November, totaling \$59k. **YTD totals:** the decrease as compared to the prior year is due to timing of purchases. Expenses to date in 2016 included approx. \$517k in textbook purchases.
- 8. Other - MTD and YTD totals:** The increase is primarily due to the increase in contracted service payments to Montgomery County ESC (\$204k in FY17/18, \$125k in FY16/17).



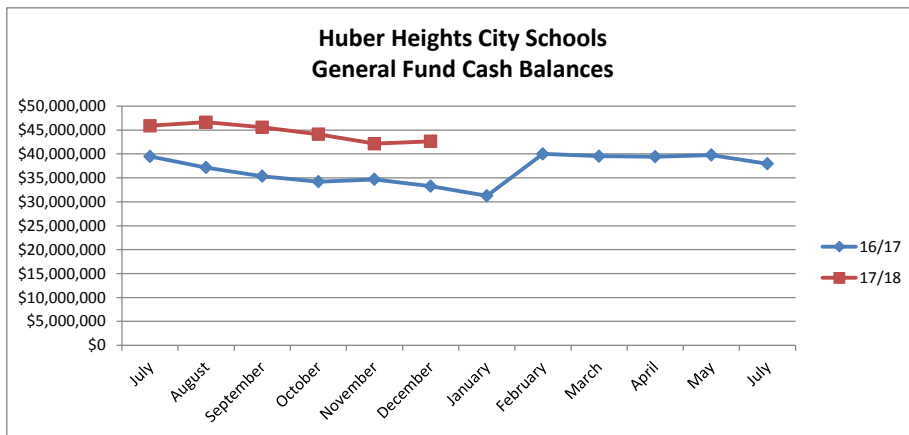
